Motion by Estes, 2<sup>nd</sup> by Seidelman to approve the agenda. Voice vote: all yes. Motion carried.

Motion by Seidelman, 2<sup>nd</sup> by Ponton to approve the previous meeting minutes. Voice vote: all yes. Motion carried.

**Village Presidents Report:** Village President Bayler suggested that running small string around the pond would help keep the geese out of the pond in Heritage Estates subdivision. This process is done at local golf courses and seems to work. Attorney Miller suggested that they contact the IML insurance to make sure there would be no issues in doing this. New lighting around the pond also needs to be considered this year. The board is in agreement to get bids for sidewalks on Heritage Road out to 136.

Finance and TIF: The TIF revenue will be a little over \$962,000.00

Public Works/Water and Wastewater: Greg Hedrick will be getting the Village an estimate on the pedestrian bridge on Sangamon Street.

Judiciary: The expedition is having issues and is not operational at this time. It is at Stuehm's now and nothing is being done at this time. Chief Bein has made personal contact with residents pertaining to Ordinance violations regarding junk vehicles.

Parks and Recreation: 3 bid requests have been received for the tennis courts. Illinois American Water will be putting a meter up at the Little League Field. Other ideas for fundraising for the fireworks will need to be considered next year now that Ingold's Grocery Store, where a donation can was set up, is closed. The Board is in agreement to allow vendor stands at the fireworks as long as they are all lined up in a row on the same side of the street.
